In line with NCD Alliance's Advocacy Priorities for this UN HLM and WHO's Global NCD Compact 2020-2030, the conversation will focus on the need to break down silos between other global health and development priorities to ensure integrated NCD action; to mobilize investment in adequate, predictable, and sustained resources for NCDs; to accelerate national implementation of NCD strategies; deliver accountability for the implementation of NCD commitments; and to engage communities to respond to population needs.
